

**ANNOUNCEMENT UNDER THE COMPANY TAKE-OVERS AND MERGERS CODE 1995  
(as amended) (hereinafter referred to as the "Code")**

Addendum to the Announcement of the Voluntary Offer by L B Finance PLC (hereinafter referred to as "L B" or "Offeror") to purchase One Hundred and Thirteen Million Three Hundred Twenty Seven Thousand Two Hundred and Sixty Eight (113,327,268) ordinary voting shares (constituting one hundred per centum 100% ) of the issued ordinary voting shares of Associated Motor Finance PLC (hereinafter referred to as "AMF" or "Offeree")

We, L B Finance PLC, a Limited Liability Company incorporated in Sri Lanka and registered under the Companies Act No. 07 of 2007, bearing Company Registration No.PQ156, being a Licensed Finance Company Listed on the Trading Floor of the Colombo Stock Exchange, having our registered office at No.275/75, Prof. Stanley Wijesundera Mawatha, Colombo 7, hereby state that our Announcement of the Offer made on 17<sup>th</sup> October 2025 shall be amended by the insertion of the following paragraph immediately after the second paragraph of Item i - **The Terms of the Offer** :

*"The Offeror declares that, based on John Paulu Irugalbandarage Nalatha Dayawansa's and Imperial Import & Export Company (Pvt) Ltd's agreement to accept the Offer in respect of a totality of 65.60% of the issued shares of AMF; upon receipt of the said shareholders' acceptances by the Offeror, **this Offer would convert into a Mandatory Offer in terms of Rule 31 (1) a) of the Code;** and*

*upon acceptance of the Voluntary Offer by the said Paulu Irugalbandarage Nalatha Dayawansa and Imperial Import & Export Company (Pvt) Ltd, an immediate market announcement will be made to that effect, informing the market that the Voluntary Offer has triggered the threshold limits of a Mandatory Offer and from then onwards, the Offer shall be a Mandatory Offer."*

This Addendum shall be read together with the Announcement dated 17<sup>th</sup> October 2025.

We, the Board of Directors of L B Finance PLC, hereby declare and confirm that this Addendum to the Announcement has been seen and approved by the Board of Directors of L B Finance PLC. As the Board, we collectively and individually accept full responsibility for the accuracy and completeness of the information in this Addendum to the Announcement and confirm, to the best of our knowledge and belief, that there are no other facts, the omission of which would make any statement herein misleading in any material respect.
