In terms of the Listing Rules of the Colombo Stock Exchange, we write to inform you that the Board of Directors of Sathosa Motors PLC by a resolution passed on 24th February 2026 approved the payment of a 1st interim dividend, as set out below:

1. Dividend per share : First Interim Dividend of Rupees Fifteen (Rs.15/-) per share.

The said dividend is subject to withholding tax.
2. Financial Year : Financial year ending 31st March 2026.
3. Shareholders' approval : According to Article 130 of the Articles of Association of the Company, the Directors are empowered to approve the payment of dividends, whether interim or final, without the need for approval by an ordinary resolution of the shareholders. Therefore the dividend payment is not subject to shareholders' approval.
4. Ex-dividend date : 6th March 2026.
5. Record date : 9th March 2026.
6. Date of dispatch of the dividend payment : Cheques will be dispatched on 25th March 2026 to those shareholders who have not provided accurate dividend disposal instructions.

In respect of those shareholders who have provided accurate dividend disposal instructions, the dividend payment will be directly credited to their respective Bank Accounts on 12th March 2026.
