In terms of the Listing Rules of the Colombo Stock Exchange, we write to inform you that the Board of Directors of Ceylon Tea Brokers PLC by a resolution passed on 23rd August 2024 approved the payment of a final dividend as set out below:

1. Dividend per share : Final Dividend of Cents Forty Four (Rs.0.44) per share.

This is a gross dividend and is subject to Withholding Tax.
2. Financial Year : Financial year ended 31st March 2024.
3. Shareholders' approval : According to Article 129 of the Articles of Association of the Company, the Directors are empowered to approve the payment of dividends, whether interim or final, without the need for approval by an ordinary resolution of the shareholders. Therefore the dividend payment is not subject to shareholders' approval
4. Ex-dividend date : 3rd September 2024
5. Record date : 4th September 2024
6. Date of dispatch of the dividend payment : Cheques will be dispatched on 24th September 2024 to those shareholders who have not provided accurate dividend disposal instructions.

In respect of those shareholders who have provided accurate dividend disposal instructions, the dividend payment will be directly credited to their respective Bank Accounts on 9th September 2024.

7. Closure of books : The transfer books of the Company will not be closed.
8. Auditors' Certificate of Solvency : The dividend payment is subject to the Company obtaining a Certificate of Solvency from the Auditors in terms of Section 56 of the Companies Act No.7 of 2007.

The following documents are attached:

1. A certified extract of the resolution passed by the Board of Directors that the Company is able to satisfy the solvency test immediately after the dividend distribution and undertaking to submit the Auditors' Certificate of Solvency to the Colombo Stock Exchange prior to the dispatch of the dividend.
2. A certified copy of the Certificate signed by the Directors that the Company is able to satisfy the solvency test immediately after the dividend distribution.
3. A certified excerpt of Article 129 of the Articles of Association of the Company.
