FIRST INTERIM DIVIDEND OF RS.5/73 PER ORDINARY SHARE FOR THE FINANCIAL YEAR ENDING 31ST MARCH 2027

We wish to inform you that the Board of Directors of Bukit Darah PLC ("the Company") has approved the payment of a First Interim Dividend of Rs.5/73 per Ordinary Share for the year ending 31st March 2027 to the shareholders.

As per Article 16 (2) of the Articles of Association of the Company, the payment of an Interim Dividend does not require the approval of the shareholders.

The total dividend of Rs.584,460,000/- would be paid entirely out of the Dividend Income received by the Company and therefore will not be subjected to withholding tax at 15% by the Company as per the Inland Revenue Act, No. 24 of 2017 and amendments thereof.

The said dividend payment would be dispatched to the shareholders as follows in compliance with the Colombo Stock Exchange Listing Rule 7.1 (c) (ii). In terms of the Listing Rules, the **Entitlement Date/Record Date** for the above dividend is **Monday, 27th July 2026**.

1st Payment – Within 03 Market Days from and excluding the 'Record Date' to shareholders who have provided accurate dividend disposal instructions to the CDS or the Company by providing their bank account number(s), - by **Friday, 31st July 2026**.

2nd Payment – Within 12 Market Days from and excluding the 'Record Date' to shareholders who have not provided accurate bank details or have not provided any bank account details, - on or before **Thursday, 13th August 2026**.
