We confirm that Directors of Singha Capital Ltd, Mr. Maheen Priyantha Ahalapa Gamage and Mr. Ukwatta Kankanamge Harith Ruwan Ranasinghe resigned from LCB Finance PLC on **23rd September 2023** and **09th December 2024** respectively.

1. That action has been taken to inform Central Bank of Sri Lanka.
2. To publish a notice in Newspaper in Sinhala, Tamil and English in relation to inaccurate information.
3. To send a Letter of Demand to Social Media Influencer
4. File a complaint at CID.
