This is to inform that the Board of Directors of ChemaneX PLC (the Company), decided to pay a final dividend of Rs.5/- per share in the form of scrip dividend, on the ordinary shares of the Company for the financial year ended 31st March 2025.

The following table reflects the number of shares to be issued, the proportion and consideration at which shares are to be issued out of the profits earned during the year which is to be set aside for the scrip dividend based on the number of issued shares as at 26th May 2025.

- The scrip dividend is subject to the Colombo Stock Exchange approving in principle the issue and listing of shares and obtaining shareholder approval in terms of the Company's Articles of Association
- The Share Transfer Books of the Company will **not be closed** in respect of the Dividend payment
