**GESTETNER OF CEYLON PLC | DISCLOSURE IN TERMS OF SECTION 8 OF THE LISTING
RULES OF THE COLOMBO STOCK EXCHANGE**

In accordance with Section 8 of the Listing Rules of the Colombo Stock Exchange, we hereby inform you for and on behalf of Gestetner of Ceylon PLC (the "Company") that World Elite Limited, a company incorporated under the laws of Hong Kong, bearing Company Registration No. 3324859 and having its registered office at No. 803 Nine Queen's Road Central, Hong Kong, has acquired by way of trades executed on the Colombo Stock Exchange on 13th October 2025, one million three hundred and twenty nine thousand one hundred and fifteen (1,329,115) ordinary shares in the Company at a price of Sri Lanka Rupees Two Hundred and Thirty Nine Cents Seventy Five (LKR 239.75) per share amounting to a total consideration Sri Lanka Rupees Three Hundred and Eighteen Million Six Hundred and Fifty Five Thousand Three Hundred and Twenty One and Cents Twenty Five (LKR 318,655,321.25). One Million Two Hundred and Sixty Three Thousand One Hundred and Ninety Five (1,263,195) shares were purchased from Gestetner (Eastern) Limited and the balance Sixty Five Thousand Nine Hundred and Twenty (65,920) shares were purchased from the market.

Following this transaction, World Elite Limited will hold a total of one million three hundred and twenty nine thousand one hundred and fifteen (1,329,115) ordinary shares in the Company, which amounts to approximately fifty decimal zero one percent (50.01%) of the issued ordinary shares in the Company.
