KEELLS FOOD PRODUCTS PLC – THE THIRD INTERIM DIVIDEND FOR THE FINANCIAL YEAR ENDING 31 MARCH 2026

We write to inform you that the Board of Directors resolved today to pay the third interim dividend of Rs.1.65 per share (Gross Dividend) for the year ending 31 March 2026, payable through SLIPS/RTGS on the 3rd market day from the Record date for shareholders with SLIPS/RTGS instructions and post cheques to the rest of the shareholders on or before the 12th market day from the Record date.

This dividend will be subject to Advance Income Tax (AIT) at 15%.
