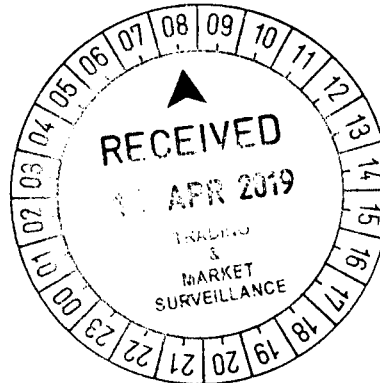

**DIALOG FINANCE PLC –  
DISCLOSURE ON THE STATUS OF THE MINIMUM PUBLIC HOLDING UNDER  
RULE 7.13.2 AS AT 31 MARCH 2019**

In terms of Rule 7.13.2(a) of the Listing Rules of the Colombo Stock Exchange ("CSE"), we write to inform you that Dialog Finance PLC (the "Company") is currently not compliant with the Minimum Public Holding requirement stipulated in Rule 7.13.1(b) of the Listing Rules due to the reasons specified in our previous announcements.

As required by Rule 7.13.2(a) the information pertaining to the status of the Minimum Public Holding of the Company as at 31 March 2019, is as follows:-

- a) The Existing Float Adjusted Market Capitalization – Rs. 28,720,165.24
- b) The Public Holding Percentage – 1.12%
- c) Number of Public Holders - 779

As previously informed, the CSE has granted an exemption to the Company under Rule 7.13.3(iii), with having to comply with the maintenance of the minimum public holding requirement, until 2 August 2019, subject to the Company making the appropriate disclosures to the market in this regard.
