FIRST CAPITAL HOLDINGS PLC

REVIEW OF OPERATIONS

First Capital Holdings PLC (the Group) recorded a Loss after Tax of Rs. 69Mn for the nine months ended 31st December 2021 compared to Profit after Tax of Rs. 1.85Bn in the corresponding period of the previous year. Trading and marked to mark losses on the government securities portfolio incurred by the Group's Primary Dealer division had an adverse impact on the Group's earnings. This was primarily caused by the upward shift in the yield curve due to the unanticipated tightening of monetary policy in mid-August 2021. However, the Group reported a Profit after Tax of Rs. 235Mn for the 3rd quarter of 2021/22 (3rd quarter of 2020/21 – Rs. 131Mn). The said results include a reversal of over provision of income tax amounting to Rs. 149Mn.

The Primary Dealer division reported a Loss after Tax of Rs. 361Mn for the nine months ended 31st December 2021 (2020/21 – Profit after Tax of Rs. 1.54Bn). The Results include net interest income of Rs. 357Mn and a trading loss on sale of government securities amounting to Rs. 809Mn (2020/21 – Net interest income of Rs. 387Mn and a trading gain of Rs. 2.5Bn were included).

The Corporate Finance division reported a Profit after Tax of Rs. 47Mn for the nine months ended 31st December 2021 (2020/21 – Profit after Tax of Rs. 218Mn). The Results include fee income on structuring and placement of corporate debt securities of Rs. 36Mn and trading gain on sale of corporate debt/equity securities of Rs. 84Mn.

The Wealth Management division reported a Profit after Tax of Rs. 77Mn for the nine months ended 31st December 2021 (2020/21 – Rs. 64Mn). The assets under management of the division stood at Rs. 44.9Bn as of 31st December 2021 (31st March 2021 – Rs. 45.2Bn).

The Stock Brokering division recorded a Profit after Tax of Rs. 176Mn for the nine months ended 31st December 2021 (2020/21 – Rs. 41Mn).

In December 2021, First Capital Treasuries PLC (Group's Primary Dealer arm) was listed on the Diri Savi Board of the Colombo Stock Exchange.

The credit ratings of First Capital Holdings PLC and First Capital Treasuries PLC were reaffirmed by ICRA Lanka Limited at "A" with stable outlook in December 2021.

The Company measures fair values using the following fair value hierarchy that reflects the significance of the inputs used in making the measurements in accordance with SLFRS 13.

Level - 1

Financial instruments that are measured in whole or in part by reference to published quotes in an active market. A financial instrument is regarded as quoted in an active market if quoted prices are readily and regularly available from an exchange and those prices represent actual and regularly occurring market transactions on an arm's length basis.

4 FINANCIAL INSTRUMENTS- FAIR VALUE MEASUREMENT (CONTD.)

Level - 2

Financial instruments that are measured at fair value on a recurring basis. As market quotes generally are not readily available or accessible for these securities, their fair value measures are determined using relevant information generated by market transactions involving comparable securities.

Level - 3

Valuation techniques using significant unobservable inputs. This category includes all instruments where the valuation technique includes inputs not based on observable data and the unobservable inputs have a significant effect on the instrument's valuation. This category includes instruments that are valued based on quoted prices for similar instruments where significant unobservable adjustments or assumptions are required to reflect differences between the instruments.
